### DESCRIPTION

Stokoderm® Grip PURE contains an active ingredient combination of an astringent active ingredient, surfactants and emollients. The product is effective against both oil-based, water-based and emulsifiable materials. Stokoderm® Grip PURE was specially developed for particularly sensitive skin and is both perfume and preservatives free.

### AREA OF APPLICATION

Changing use of water-soluble and water-insoluble materials and/or activities in changing work areas. Not clearly defined and unspecific skin risks. Stokoderm® Grip PURE can also be applied under gloves.

### INSTRUCTIONS FOR USE

Carefully apply Stokoderm® Grip PURE to clean and dry hands, including the nail beds and between the fingers. If required, apply to further parts of skin. To maintain the protective effect, regularly apply Stokoderm® Grip PURE before work and after long work breaks.

### Skin Compatibility Tests

The skin compatibility of Stokoderm® Grip PURE was carefully tested under laboratory conditions and medical guidance. In these tests, as well as in practical use, Stokoderm® Grip PURE has proven to have very good skin compatibility properties. Medically certified skin compatibility expert reports prepared by Prof. Dr. med. S. W. Wassilew, MD for Dermatology, Allergology, Environmental Medicine, are available upon request.

### Testing the Efficacy

The protective action of Stokoderm® Grip PURE was tested on the analogue product with preservatives using the modified Repetitive Occlusive Irritation Test (ROIT), a modern skin physiology in vivo process (Evonik Industries, Krefeld). The protective action was tested. The model irritants are occlusively applied to the skin twice a day for 30 minutes over a period of four days. The resulting skin irritation is defined and compared with the help of the visual score (VS); the resulting barrier damage with the help of the transepidermal water loss (TEWL).

### Statutory Regulations

Stokoderm® Grip PURE is governed by the Cosmetics Regulation of the EC, and is not subject to the Chemicals Act or the Ordinance Regulating Hazardous Substances.
