**Description:** Perfume-free, water resistant 5 Star rated SPF30 sunscreen for professional use to protect the skin against UV-A and UV-B exposure.

**Usage:** For use on any part of the body exposed to the sun whilst working outdoors. Suitable for all skin types.

**Method of Use:** Apply to clean, dry skin 15 to 20 minutes before outside exposure to sunlight and again as you go outside, or once outside. Re-apply liberally every 2-3 hours, or more frequently if perspiring.

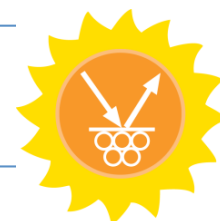

## Product Testing

Test Type	Comment
Dermatologically Tested	The <i>48hr Single Patch Test</i> results have been validated by a dermatologist to show the product to be 'non-irritant'.
Toxicological Approval	Formulation assessed by a Toxicologist and declared safe to use.
Assessment of UVA-PF <i>In vitro</i>	Determined according to COLIPA Guideline 2007.
UV-B Efficacy Test <i>In vivo</i>	Using the International Sun Protection Factor Test Method (Feb 2003), the SPF was determined along with the claim for water resistance.
UVC Efficacy test <i>In vitro</i>	Using a modified COLIPA Guideline, the trapezium rule was used to establish that product provides 35 times more UVC protection than using no product.
Ocular (Eye) Irritation Test <i>In vitro</i>	Results show product is not irritating to eyes.
Boots® Star Rating <i>In vitro</i>	Test method developed by Boots® uses a spectrophotometer to measure the absorption ratio of UV-A compared with UV-B. The product achieves 5 STARS, the highest rating.
