PROCESS STAGE	POTENTIAL RISK	CONTROL MEASURES	ACTION REQUIRED
<b>DELIVERY</b>			
Packaged in 5 litre polythene containers in a cardboard carton.	Risk of spillage if the container is dropped.	Trained employees should handle only single containers at any given time. Take care not to drop the containers. Ensure that the cap is secure at all times.	Transfer bottles to store immediately following delivery. Do not leave bottles in areas where users of the building will come into contact with them.
<b>STORAGE</b>			
Store product securely in a cool, dry, well-ventilated area. Keep away from strong acids, strong alkalis. Avoid excessive heat for prolonged periods of time. Product must be kept stored in its original container.	Minimal risk of spillage if bottle lid is firmly in place. Lids are not child proof.	Restrict access to storage areas to authorised personnel. Keep the store well ventilated. Clear up spills immediately. Ensure that product is stored away from substances that contain oxidising agents.	Store containers so their labels face forward. Use oldest stock first. Make regular checks to ensure that bottles are not split or blown/damaged.
<b>USAGE</b>			
Product is sprayed directly on to surface where it cleans and disinfects in one action. Follow instructions on label for contact time.	Risk of eye contact or damage. Risk of skin contact. Risk of ingestion. Risk of inhalation. Risk of spillage to the floor and drainage system.	Handle with care. Ensure that the bottle is returned to the store when not in use. Always read the manufacturer's instructions prior to use. Ensure that all spillages are wiped up immediately.	Provide employees with PPE as follows: <ul style="list-style-type: none"> <li>Chemical resistant gloves EN 374 or equiv.</li> <li>Safety glasses EN 166</li> </ul> When mixing solutions, ensure that operatives add product to water Ensure that operatives are aware of location of First Aid facilities.
<b>DISPOSAL</b>			
Discharge used solutions into drain. Small amounts (less than 5 litres) of unwanted product may be flushed with water to sewer. Consign empty containers to normal waste.	Small risk of skin or eye contact.	Wash out the container using plenty of water. Do not store any other material in the empty container. Ensure that the product is exhausted before disposal.	Ensure that all operatives wear Personal Protective Equipment at all times during disposal.
