A159 is a Cosmetic Product which contains: Aqua, Sodium Laureth Sulfate, Sodium chloride, Cocamide DEA, Glycerin, Parfum, Benzyl Alcohol, Chloromethylisothiazolinone, Methylisothiazolinone, Triethylene Glycol, Propylene Glycol, Magnesium Chloride, Magnesium Nitrate, CI 42051.
