3. HAZARDS IDENTIFICATION

Main hazards: Extremely flammable.

Other hazards: In use, may form flammable / explosive vapour-air mixture.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be irritation and redness. Corneal burns may occur.

Ingestion: Nausea and stomach pain may occur. There may be vomiting and diarrhoea. There may be loss

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

Ingestion: Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If

unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. If unconscious,

check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. If conscious, ensure the casualty sits or lies down. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to

hospital as soon as possible.

5. FIRE-FIGHTING MEASURES
